

Re – Annual Report 2006/2007

Further to my letter of 19th February 2008, your email of 5th March 2008 and our subsequent telephone conversation, I hold the opinion that the adjusted final accounts for the above period should be presented in format as undertaken in Zonta's Report to Members dated 6th August 2007.

Also, whilst the above amended report now excludes amounts accrued in 2005/2006 financial period, it does not include the additional adjustments stated in my letter of 19th February, 2008.

It is accepted that the overall position is now correct, the reported profit for both divisions is not.

the amended 2006/2007 Financial Report is approved for presentation to its Members for their approval.

Finally, it is hoped that the level of internal controls undertaken by Zonta Club of Perth, as raised in my letter of 24th June 2007, with respect to processes / procedures undertaken by its Treasurer including those of the Finance Committee are improved, and accounting procedures applied in prior years are incorporated in the preparation of the 2007/2008 accounting reports.

This has been an exciting year of significant growth and continuous change for the Club particularly due to the outstanding leadership of our Board members and Committee Chairs.

Our new financial year started with much energy and excitement as a large contingent of Club members showed their enthusiasm and support of Zonta International by attending the International Convention held in Melbourne in June 2006. There, we participated in fellowship and were provided wonderful opportunities to learn more about Zonta at the global level.

Additionally we took the opportunity to showcase our Club and in particular our Ngarinyin Project which captured the hearts and minds of many Zontians, nationally and internationally. Leading on from this exposure our Club has recently had approval at District level to put forward the Yarri Wada Puppet Project which has evolved from our relationship with the Ngarinyin Community. Well done

Karen Groves and members of her Ngarinyin Committee in their efforts thus far.

Furthermore our Membership & Support Committee under the leadership of Sandy McGregor has had outstanding success in recruiting eleven new members and we have successfully reached our Club target of 40 members for this year. The information evenings which are used to profile our Club have proven to be an extremely successful way of informing prospective new members about Zonta International and the projects that our Perth Club is involved in. The new mentoring program which has been instigated has also been an important strategy in attracting and retaining new members.

Our Finance and Fundraising Committee under the strong leadership of Sciona Browne has worked hard at developing sound financial systems and practices to secure the effective financial management of the Club. In my view we as a Club are leading the way in relation to looking at innovative ways to raise funds particularly from grants monies, to support the purchase of important



Club assets and to fund our projects. The work undertaken thus far has positioned our Club very well for the next 12 months in relation to our project development.

Annually our Club receives great recognition for our public relations efforts and publications and the Club is extremely grateful to Chair of that committee Carole Theobald and her PR committee who have been outstanding yet again in developing and maintaining our website and producing our award winning Inzert.

Carole in particular needs to be commended for her super human efforts in managing the Club's PR while she is often at her "second home" in Indonesia. The PR committee has also successfully promoted our major fundraising events and obtained important media coverage which has significantly contributed to raising the profile of Club this year. Carole has also recently produced a DVD which captures the history of Zonta and professionally portrays the accomplishments of the Perth Club. We have now started showing the DVD at our information evenings to

prospective new members. Our Status of Women committee continues to administer the established awards and programs of our Club, and in so doing, are attracting high calibre award recipients. The main fundraiser of the year, 'The Luck O' the Irish Lunch', held in March at Perth Racing's Ascot track, was a huge success. Not only was this event a success in terms of raising funds for Zonta, but the whole Club supported it and it engendered the commitment of teams working together that is a hallmark of Zonta.

Members from all Committees entered into the spirit of this event and gave huge amounts of their time and expertise. Our amazing Carole Theobald and her PR team did an outstanding job. Membership and Support also jumped in, not to mention individuals throughout the Club all of whom contributed to this event, attended and sold tickets to others and made the day a show-stopper! The St Patrick's race day event was indeed 'lucky'... we were able to bring in just over \$7,500 net.

The Club raised over \$12,000 in cash this year for Zonta, and when the successful small equipment grant is added in, close to \$15,000 in total. \$6,000 above budget.

While the Finance and Fundraising Committee is responsible for organising fundraising initiatives, we simply could not achieve these

results on our own. It is the support of the Club as a whole and individual members that counts at the end of the day.

NGARINYIN COMMITTEE

Karen Groves

Embracing some clear strategies to develop the relationship with the Ngarinyin women, this committee has moved forward on a few significant initiatives over this past year. The four goals have been:

1. To host the Ngarinyin women on a visit to Perth to consolidate the friendship with the Club:

A formal visit to Perth by the women elders did not eventuate but visits by their community nurse Angie Fisher and other members of the communities gave us the chance to connect and extend the



friendship and understanding between the Kimberley communities and our club.

Artist Lucy Ward was in Perth at an exhibition of her paintings at Indigenart Gallery and was reacquainted with some of the members who went on the trip in 2004.

During a health trip to Perth, Pansy Nulgit's daughter and son-in-law were given a splendid, healthy meal and valuable dietary advice by Sciona Browne, Fiona Crowe and Wendy MacGibbon. Kathy Charlesworth remains an important link with the women elders and she assures us that the strength of the relationship is felt and understood equally by them.

2. To introduce an Emerging Artist Award for a Ngarinyin Artist:

This project has been shelved for the time being as collective wisdom decided that it was not the right time for this concept. Our mentor, Dr. Mary Anne Jebb (historian and curator of the Mowanjum Arts Centre) was most helpful in guiding us to this decision. The Club was privileged to hear Mary Anne speak at a Club Meeting on her life and work with

the women elders of the Kimberley, told largely through her relationship with her own woman elder and "mother" figure.

3. To remain poised to respond to the needs of the Ngarinyin women—always:

Significant opportunities presented themselves in this regard. In June 2006, Club members contributed to a monster clothing collection in response to the call from the communities for clothing in the winter months. The logistics of collecting, packing and shipping the clothes involved a large number of Club members. Peter Zaluzny of Pacific Transport got behind the effort and transported the shipment to the Kimberley at almost no cost. He has remained a significant supporter of the Ngarinyin Project and again shipped another collection of clothing from St. Catherine's College in January 2007.

Yvonne Burgu at Gibb River has indicated a need for fishing gear for the children so that they can enjoy catching their own fish. A donation from a Californian Zontian, Pat Johnson, has been earmarked to be spent on fishing lines.

It's all in the bones! The year kicked off with our first event, The Bone and Fundraising Event, held on the 19th July. Fiona Crowe, gave a riveting account of the life and times of ancient Roman 'hunks' through a study of their bones... Zonta Club of Perth members and fellow Zontians from Northern Suburbs and Swan Hills, spent a weekend trekking on the Bibbulmun Track.... sore feet notwithstanding, sleeping under the stars was a very bonding experience! Other members, their husbands, partners and friends joined us on the Sunday, for brunch at the Mundaring Weir Pub.

One of our most successful fundraisers this year was the Wine Raffle. Members got right behind this initiative and I wish to acknowledge and thank you all for your generosity and support. We raised close to \$4000 on this event alone. The idea for the raffle came from Debbie Mason and, with a few tweaks learned from experience this year, we think it is well worth considering another in the future.

We had a mixed result with application for grants. The Living in Harmony grant for the Indigenous Mentoring Project did not get up, but we have been invited to reapply in 2007/2008. Apparently, it was a narrow decision not to fund us this year, but we are encouraged by the invitation to submit a second application.

The success goes to Anne-Marie McNaughton, assisted by Kaye Martin, for the grant application for a laptop computer for the Club. A Volunteer Small Equipment Grant of \$2800 will mean the Club can now buy a new laptop to be used by the Club Treasurer and we may also have enough to purchase a printer.

FINANCE AND FUNDRAISING

Sciona Browne

The Finance and Fundraising Committee has had a busy and productive year. Members, with the exception of stalwart Wendy MacGibbon, were all new to this committee. It was a steep learning



The ever-present plight of the Kimberley communities, facing diminishing health and violent domestic situations, has caused the women to ask for help in educating their young children in acceptable social behaviours, cultural values and health practices. With the determination of Angie Fisher and the passion and diligence of Fiona Crowe, the "Yarri Wada: Strong for Country" Puppet Project has been developed.

The concept is to involve the Ngarinyin people in designing and making the puppets, creating the dialogues, telling the stories and thereby, educating their young children – for a viable community life, blending traditional cultural values with modern practices to achieve a safer, healthier and more productive environment.

This project is poised for further development and will involve significant commitment by our Club. The concept has also won approval from the Board of District 23 to be put forward for consideration as a District Project at the District 23 Conference in Hobart in September 2007.

4. To plan a visit to the Kimberley by Zonta Women in 2007:

A trip in June/July 2007 is being planned as this report is being written. It is thought that this expedition will be organized to be self sufficient with the Zonta women doing the driving, camping and cooking rather than going with an organized tour company. The meeting with the Ngarinyin women will be focussed around Gibb River and the visit will be timed to coincide with the Mowanjum Arts Festival. We are fortunate to have the good services of Katina Law working on the trip plans – her local knowledge will be invaluable!

Other matters:

Apart from pursuing these goals, the Committee has expanded its consideration to include a special project involving indigenous women in Perth. This was developed through the passion and dedication of Fiona Crowe, Principal of St. Catherine's College at UWA and a member of the Australian Federation of University Women (UFUW), a partner in the "Yarri Wada Project" – a mentoring program for indigenous students living in college and studying at UWA.



Club members have been given the opportunity to mentor these students according to their individual needs – academic assistance, work experience or “mothering”.

Significant scoping went in to the establishment of this project, ascertaining existing mentoring facilities and other interested parties, so the end result is seen as an excellent model on which to base further development.

The other area of activity which has been largely championed by Sciona Browne is in the field of *advocacy*.

Sciona has raised the awareness of indigenous issues in general and the Zonta Club of Perth’s Ngarinyin Project and extraordinary friendship with the women elders through her many and varied approaches to prospective project partners, possible grant givers and influential contacts.

Huge exposure was given to the project at the Zonta International Convention in Melbourne in June 2006, including a personal meeting with ZI President Mary Ellen Bittner. Invitations to speak followed from the District 24 Board and the Zonta

Club of Noosa for International Women’s Day.

Other meetings were held with Indigenous Enterprise Partnerships (IEP) in Melbourne and Edge of Nowhere (EON) Foundation in Perth. Presentations were made at the Melbourne conference of the International Council of Small Business and at the “Engaging Indigenous Issues” Conference in Brisbane.

It is imperative in this report to acknowledge the support and enthusiasm of Carole Theobald who has been instrumental in preparing Power Point presentations, cataloguing Kathy Charlesworth’s photos of the Kimberley people and producing wonderful PR materials to support this project.

While some members of this committee are passionately involved in these projects, and are to be congratulated on their achievements, all members are supportive and sincere in their valuable contributions.



Our committee has developed a range of new resources this year including:

- A large, laminated club poster featuring Zonta activities
- Laminated posters to promote the Zonta Raffle at Bunnings’ stores

- PowerPoint presentation of the Ngarinyin project used at International Convention in Melbourne

forwarded to Kathy Charlesworth and has been shared with our Ngarinyin friends in the Kimberley, who do not have access to computers, but do have DVD players and televisions. The DVD of the Welcome to Zonta presentation was set to music and used at the Luck of the Irish Lunch.

Recently, Mary capably managed our Club’s stand at the International Women’s Day event at the Hyatt Hotel that attracted over 650 participants. The stand featured our self standing banner and display board featuring the club’s new eye-catching large poster as well as a range of award posters and desk top display file of Zonta activities. Mary and Margaret also managed a display of our Club’s projects for the Area 3 workshop.

Internal communication

Keeping members informed about our Club’s activities is a major role of the PR committee.
